In addition to rules and regulations changes as a result of the passage of LB 1140, the State Board of Landscape Architects is amending for clarification, and adopting new rules to reflect current Board policy. - Require that reciprocal license applicants hold a Council of Landscape Architectural Registration Boards (CLARB) record
- Modify provisions related to examination administration
- Change the term “registration” to “licensure”
- Add provisions concerning requests for lists of licensees or applicants
- Modify provisions for classification of applicants for licensure
- Clarify the required fee submittal period for approved license application renewals
- Update applicable language to correspond with CLARB model law recommendations





No members of the public appeared to give oral testimony during the Rules Hearing.


C Adoption of the Rules and Regulations
